This conclusion is supported by the fact that Jackson did not regard Watson as a favored employee, but "wanted to do [Watson] in" instead of supervise her. Given these facts, we believe that Jackson's repeated denials of any knowledge of Watson's allegations were properly considered by the trial court in evaluating the overall credibility of his testimony. [6] The fact that a state employee is excluded from the protection afforded under a federal employment discrimination law does not, of course, place the employee at a greater risk of losing one's job than a private-sector employee.
